Prof. Dr. Iqrar Ahmad Khan (S.I) Vice-Chancellor University of Agriculture Faisalabad highlighted access to finance as one of the major challenges faced by small farmers. The collateral requirement by the financial institutes was a big hindrance towards easy access to finance.

The Vice-Chancellor emphasized n the need to motivate young population for getting involved in Agriculture. He expressed that Agri-Entrepreneurship was the way forward and suggested BOP to introduce a clean financing scheme that could help early-stage Agri-Startups. He said these kinds of diverse partnerships were crucial for benefiting the rural communities.

Ms. Alia Zafar, Group Head People, and Organizational Excellence Group, BOP said that Financial inclusion was an important step towards inclusive growth. It helps in the overall economic development of the rural population.

# ORIC STARTED FOUR-WEEK PROFESSIONAL TRAINING FOR OFFICERS OF AGRICULTURE DEPARTMENT (RESEARCH WING)

Four-week professional training on Finance, Administration, Management and E-Governance for the officers of Agriculture Department Punjab (Research Wing) commenced at University of Agriculture Faisalabad (UAF) arranged by ORIC. It is the fourth batch of the series of trainings. In the fourth session, as many as 79 participants were being capacitated through handout training. The inaugural ceremony was presided over by UAF Vice Chancellor Prof Dr. lgrar Ahmad Khan(SI). He urged the agricultural scientists to work with dedication and come up with valuable research work to address the agricultural problems especially troubleshooting for the small farmers in order to increase the agricultural productivity. He said that hard work had no substitute.
